



SantaLash 2009 Terms & Conditions

Please read these carefully, making a purchase from this site indicates that you accept these terms fully.

We only issue electronic tickets, via email, using the eTickets.to system. You will be asked to present this email and the validation code in the email to gain admission to the event. Failure to do so may result in refusal of admission for which SantaLash cannot be held responsible.

eTickets.to provide the platform for this transaction but your purchase and contract is made directly with SantaLash who is responsible for resolving any issues with you.

All payments will be processed using Google Checkout. SantaLash will not enter into any dispute between you and Google Checkout should payment be debited from you, but does not reach us. Tickets will be voided if your payment does not reach us via the Google Checkout system within 5 working days.

If for any reason you do not receive your email ticket please email headsanta@santalash.co.uk. We may request proof of purchase (e.g. credit/debit card statement) in order to re-issue your e-ticket.

Ticket Terms and Conditions

1. This ticket is issued subject to the rules and regulations of the participating venues, seOne Nightclub, and SantaLash.
2. You participate in SantaLash (“the event”) entirely at your own risk. No liability will be accepted for loss, damage or injury to persons or property during the event.
3. All establishments included on the SantaLash route are licensed premises and admission is at the discretion of the licensee or the designated premises supervisor. Venues may conduct security searches to ensure the safety of the patrons.

4. You are strongly advised not to consume alcoholic drinks throughout the event and you are under no obligation to drink alcohol in order to participate. We recommend you alternate with soft drinks throughout the event. Visit <http://www.drinkaware.co.uk/> for more information on drinking responsibly.

5. The organisers and licensees of establishments on the route will not tolerate antisocial behavior of any kind either inside premises or whilst walking between establishments. Any participant who engages in such behavior will be denied entry to all venues along the route and the after-party at seOne nightclub.

6. You will be required to keep your SantaLash identification (provided upon registration at the event) with you at all times during the evening. Without this identification you may not be allowed entry to the licensed premises on the route or seOne nightclub. SantaLash reserves the right to make a charge for entry to seOne if you have lost your identification.

7. We regret that tickets cannot be exchanged or refunded after purchase. SantaLash cannot be held responsible for any tickets which are lost or stolen. SantaLash reserves the right to cancel ticket bookings which it reasonably suspects to have been made fraudulently.

8. Tickets are sold subject to the management's right to alter or vary the programme due to events or circumstances beyond its control without being obliged to refund monies or exchange tickets.

9. If this ticket is re-sold or transferred for profit or commercial gain by anyone other than SantaLash or one of their authorized sub-agents, it may be voided and the holder may be refused entry to the event.

10. The ticket holder must comply with all relevant laws, safety announcements and venue regulations whilst attending the event.

11. It is the responsibility of the ticket holder to ascertain whether an event has been cancelled and the date and time of any rearranged event. If an event is cancelled or rescheduled, we will use reasonable endeavors to notify ticket holders of the cancellation. Please note that we cannot guarantee that ticket holders will be informed of such cancellation before the date of the event.
